The Ministry of International Affairs and Cooperation of the Republic of Botswana presents its compliments to all resident Diplomatic Missions and International Organisations in Botswana and wishes to share the contents of a Press Statement released on the 19th October 2016 by the Ministry of Nationality, Immigration and Gender Affairs informing the general public that it has imposed requirements for minors (children under 18) travelling through the country's ports of entry.

It states that, effective from the 1st October 2016 minors travelling through the country's borders will be required to produce certified copies of unabridged birth certificates in addition to their valid passports. In the event that one parent is not travelling with the child, the other parent's affidavit consenting to such travel should be availed. However, if the father's name does not appear on the child's birth certificate, an affidavit will not be required.

The development which is aimed at managing the movement of children across the country's borders has the ultimate goal of tackling human trafficking which is a global challenge. Botswana, like other countries is affected by this problem and as such has enacted the **United Nations Anti Human Trafficking Protocol**; which calls upon governments to come up with deliberate measures aimed at combating human trafficking.

Attached to the Note Verbal is a detailed table of the requirements, covering most, if not all, situations a minor may be travelling in. Further, please note that these requirements apply only to Botswana. Travelling parties are requested to inform themselves of travel requirements for other countries of destination.

The Ministry of Foreign Affairs and International Cooperation of the Republic of Botswana avails itself of this opportunity to avail to all resident Diplomatic Missions and International Organisations in Botswana the assurances of its highest consideration.

**REQUIREMENTS FOR MINORS TRAVELLING THROUGH ALL BOTSWANA
PORTS OF ENTRY**

The Ministry of Nationality, Immigration and Gender Affairs informs the general public that it has imposed requirements for minors(children under 18) travelling through the country's ports of entry.

Effective from the 1st October 2016 minors travelling through the country's borders will be required to produce certified copies of unabridged birth certificates in addition to their valid passports. In the event that one parent is not travelling with the child, the other parent's affidavit consenting to such travel should be availed. However an affidavit will not be required if the father's name does not appear on the child's birth certificate.

The development which is aimed at managing the movement of children across the country's borders has an ultimate goal of tackling human trafficking which is a global challenge. Botswana, like other countries is affected by this problem and as such has enacted the **United Nations Anti Human Trafficking Protocol**; which calls upon governments to come up with deliberate measures aimed at combating human trafficking.
